Re: VRA change to SSR's

As you may have seen, the VRA recently released a statement to their members allowing them to shoot any projectile up to 156gn. This was to be in effect for 12 months.

The NRAA Chair and Vice Chairperson have meet with VRA to discuss the implications of the above and are working through a solution to ensure their members are still fully covered to participate in our sport.

This has opened up a discussion around the legality of the directive from VRA and the shortages of projectiles. We would like to address these individually and reassure you the board has our sport's best interest in the forefront of our discussions.

VRA Change to SSR's

The implications of the VRA's decision were discussed at length by the board and we understand your concerns. The advice from the VRA to its members is in direct conflict to the NRAA Constitution which outlines that the NRAA mandates the Standard Shooting Rules for our Members. Abiding by this requirement is important to ensure that all members have a fair and equal playing field, that all participants in our sport be covered by the insurance provided by the NRAA and that Range approval requirements are met.

After discussions with the VRA Chairman and Vice Chairman we have been made aware of the VRA's situation and the reasons for the decision. We have been able to source a quantity of projectiles from the S&T that had stock on hand to ensure that VRA members are able to participate in the VRA Queens and National Teams Matches.

The VRA have agreed to repeal their decision and it was agreed by both parties that due to members already having invested in non-approved projectiles, they be allowed to use these for Club and VRA prize meetings until the 1st July 2022.

We would like to thank the VRA for working collaboratively with the NRAA to ensure a positive outcome.

Projectiles

As most will be aware, the NRAA had flagged the issue of component shortages at the members Forum 2020 and have been working tirelessly on sourcing projectiles and primers for the members. The long lead times for the projectiles being ordered to shipment date have been a hindrance to supply.

Currently the NRAA are awaiting on a shipment of 360,000 155gn , 20,000 6.5 140g and 40,000 80gn Sierra projectiles that are due to land at the end of February. This is part of an ongoing delivery of 1 million projectiles that were ordered in March 2020, which include 6 , 6.5 and 7mm projectiles to ensure that our F Class members can continue to shoot.

The Berger 155.5 projectile shipment information is unavailable at this time, QRA are doing everything they can to ensure supply.
