Ammunition – George Edser

During 2013 Winchester became the distributor of ADI Powders manufactured by Thales Australia Ltd. As could be expected some teething problems were experienced with supply and distribution to the States and Territories. It was necessary for Winchester to meet and comply with the different transportation requirements for each State and Territory.

A storage facility on the Belmont complex obtained statutory approval also during 2013 and provided a further storage point and now assists in the stockpiling of the various products for distribution to members. States and Territories have been requested to implement a similar ordering proceeds as is used for loaded ammunition.

We have recently been informed by Winchester that 2206H is now back in stock and should be readily available in sufficient and ample quantities.
