# 1. COMMONWEALTH GAMES

## 1.1 DEFINITION

Fullbore rifle shooting is contested as a Commonwealth Games sport with competition every four years, interspersed with the Olympic Games, i.e. 1990, 1994, 1998, 2002, 2006, 2010.

## 1.2 BRIEF HISTORY

Australia first fielded a fullbore team in 1978 and at each subsequent Games with marked success.

## 1.3 TEAM COMPOSITION

Teams are restricted to two (2) firers and one manager from each member country.

## 1.4 SELECTION PROCEDURES

Two shooters and one reserve will be selected by the NRAA for endorsement by the National Peak Body (Shooting Australia). Selection of firers shall be based on an elimination process over an endorsed program of Australia Cup events. The Manager shall be selected by the two successful firers or alternatively by calling of nominations.

## 1.5 TEAM MANAGER

The Manager is responsible for the logistical support of the team and should be competent in the areas of administration, travel, finance, sponsorship and international protocol. The Manager will prepare a financial budget. Within a period of two months after the conclusion of the Match, the Manager shall submit a statement of accounts detailing how grants and other team funds were expended.

## 1.6 COMPETITIONS

The rules for competition are laid down by the CGF.

## 1.7 GENERAL

Rifles, equipment, position, targets, scoring and conduct of shooting shall be in accordance with the current Rules as approved by the CGF.

## 1.8 UNIFORM

As prescribed by the Australian CG Association.

## **2. COMMONWEALTH SHOOTING FEDERATION CHAMPIONSHIPS**

### **2.1 DEFINITION**

The Commonwealth Shooting Federation (CSF) Championships are generally conducted in the year prior to the Commonwealth Games (CG) on the CG venue range. They have been scheduled at other times in the past.

### **2.2 TEAM COMPOSITION**

Teams are restricted to three (3) firers and one manager from each member country. Generally the two selected members of the CG Team will compete in the Pairs match and the reserve or third shooter will compete in the Badge match. All members compete in the Individual "Queens Prize" competition.

### **2.3 SELECTION PROCEDURES**

As per the CG Team.

### **2.4 TEAM MANAGER**

The Manager is responsible for the logistical support of the team and should be competent in the areas of administration, travel, finance, sponsorship and international protocol. The Manager will prepare a financial budget. Within a period of two months after the conclusion of the Match, the Manager shall submit a statement of accounts detailing how grants and other team funds were expended.

### **2.5 COMPETITIONS**

The rules for competition are laid down by the CSF.

### **2.6 GENERAL**

Rifles, equipment, position, targets, scoring and conduct of shooting shall be in accordance with the current Rules as approved by the CSF.

### **2.7 UNIFORM**

As prescribed by Shooting Australia.

## 3. OCEANIA TEAMS

### 3.1 GENERAL

Entry is open to affiliate member countries of the Oceania Shooting Federation. It is a multi disciplined event. NRAA are invited to submit teams. All individual entries must be nominated by the National Body. All teams across the board are 3 person teams. Each country is permitted to field a maximum of 2 teams per section. A Manager shall also be appointed. Rules and Conditions are as per the Oceania Shooting Committee submitted at time of competition.

### 3.2 NRAA QUALIFIED TEAMS

### 3.4 TEAM MANAGER

Within a period of two months after the conclusion of the Match, the Manager shall submit a statement of accounts detailing how grants and other team funds were expended.

### 3.5 UNIFORM

As prescribed by Shooting Australia.

## 4. WORLD LONG RANGE TEAM CHAMPIONSHIPS

### 4.1 HISTORY

This World Long Range Team Shooting Championship Match began in 1876 at Creedmore, USA. It was then known as “The Great Centennial International Long Range Match”. Two years later in acknowledgment of a generous donation of \$1000 by Senator Palma it was renamed The Palma Match.

The inaugural match in 1876 in which an Australia Team competed, was won by the United States. It is the oldest international match still fired in the world and has continued despite changes of technology in equipment from muzzle loading rifles to our present high powered rifles and saw the introduction of the canvas target. The first telephone communication used on a rifle range was during the Palma Match in 1897.

This match was not fired regularly; no doubt travel arrangements and costs were a contributing factor. In 1901 match conditions were adopted that formed the basis of the present competition: one days shooting of fifteen shots at 800, 900 and 1000 yards with teams of eight using rifles of the type used by the military arm of that country. In 1903 Great Britain hosted the match and Australia competed for the second time. US, Canada, France, Natal and Norway also competed. Russia accepted, however their use of the Julian calendar led them to believe the match would be fired 13 days later. United States won the match, but the rifles they used were plainly not of the type used by their military arm. Following an exchange of correspondence regarding this matter, the match was declared void and the trophy returned to England, where it was accepted without claim to victory. Competitions were fired in 1907, 1912, 1913, 1924 and 1928.

The Palma Trophy was turned over to the United States Government in 1925 and in 1930 the trophy was hung on the wall of the State War and Navy building near the entrance to the office of the Secretary of War. That was the last that was heard of it, the 2 metre (approx) high trophy simply disappeared.

The match was then not fired until 27th August 1966 at Camp Perry and since at intervals of one, two and three years, the longest run being yearly from 1966 to 1974. The administration & conditions has undergone changes. Once the host nation supplied the rifles which could be purchased by the competitors, now the competitors provide their own. In October 1977, the rules were revised to overcome problems regarding cost of promoting the match at unspecified intervals. The match is now a triennial event and some variation to team size is permitted. Metric distances were also a recognised alternative; in addition, matches at other distances may be approved. After 1982 rifles approved for use by the Palma conditions must be within criteria of those approved by the various national bodies, however, ammunition must be supplied by host countries on request.

In 1985 a Palma Council was raised consisting of one representative from each National Association or Federation that had participated in three Palma Matches. At the meeting of the Palma Countries in Bloemfontein, South Africa, it was agreed to rename the Palma Match, The World Long Range Shooting Championships.

At the meeting of the International Confederation of Fullbore Rifle Associations [ICFRA] in July 2003, it was unanimously agreed by all full member countries of ICFRA that ICFRA would manage and control the WLR Teams Championship [which would compete for the PALMA trophy (team) and Fulton Trophy (individual) and the WLR Individual and the World Veterans Championships.] All rules and conditions will be set by ICFRA and cannot be changed from country to country.

## **4.2 DEFINITION**

This specialised long range teams match is open to all shooting countries to contest the Palma Trophy over ranges 800, 900, 1000 yards or 700, 800 and 900 metres as applicable.

## **4.3 TEAM COMPOSITION**

The rules re team composition have varied although currently the teams consist of sixteen (16) firers, four (4) wind judges, one (1) team coach, one (1) captain, one (1) manager and two (2) reserve shooters. Maximum team size is 25.

## **4.4 SELECTION PROCEDURES**

NRAA Selection Criteria as approved at the time. Refer to Section 7 for further details.

## **4.5 COMPETITIONS**

The rules and conditions for the match are set by ICFRA which meets at each Championship.

## 5. AUSTRALIA MATCH

### 5.1 HISTORY

In 1906 Col. J M Templeton CMG, Chairman of the Commonwealth Council of the Rifle Association of Australia, announced in Bisley the commencement of an Imperial Match and invited the NRA of Great Britain to compete in Australia. By 1907 it was confirmed that a team from Great Britain would visit and a public fund initiated by General Hoad rapidly raised 250 pounds. A challenge shield constructed entirely out of Australian materials was designed and made by the firm of Messrs Linton & Vanzetti of Perth, WA.

The first "Empire Match" was held at Randwick Rifle Range between teams of eight from Australia, Great Britain and New Zealand. Match conditions were ten counting shots over 200, 500, 600, 800, 900 and 1000yds. The match was won by Australia. [A. Cutler, who top scored for Australia with a four point lead over all team shooters, was the father of a future Governor of NSW, Sir Roden Cutler]. In 1910 the shield was taken to Bisley by Lt.Col. JJ Paine and was won by GB and remained in the care of the NRAGB. In 1987 the trophy was returned to Australia and was refurbished by the Sydney firm of Amor-Sanders.

A condition of competition is that Australia must always be present before the trophy can be competed for. As a result, it is one of the most prestigious events in the international shooting calendar. Australia has (up until 2008) won the match on 19 occasions. In 1988 Australia's Bicentennial year, this match was renamed the Australia Match and the competition, formerly restricted to member countries of the Commonwealth, was opened to all shooting nations allowing the United States to compete for the first time. Countries who have competed are New Zealand, Great Britain, Canada, India, South Africa, West Indies, Rhodesia, Jamaica, Channel Islands, Kenya, Jersey, Guernsey, Bermuda, United States. Participation of an Australian Team remains as the main criteria for staging the match.

### 5.2 DEFINITION

The Australia Match has been acknowledged as the most prestigious international match alongside the WLRTC (Palma Match). In 2003, it was agreed that the Australia Match was to be controlled by ICFRA and it will generally be scheduled at four year intervals in between Palma Matches. It now may be contested at any international meet at which Australia has a team in attendance.

### 5.3 SELECTION PROCEDURES

If selection is necessary from a touring team, it will be made by team management using current performance data. If the match is to be contested by dedicated arrangement the team will be selected as per current Selection Policy. Refer to Section 7 for further details.

### 5.4 CONDITIONS

The Match may only be conducted when an official Australian team is present and competing. ICFRA is now the controlling body for setting future matches and rules and conditions.

### 5.5 TEAM COMPOSITION

Teams shall consist of a Captain, a Manager, Master Coach, two Coaches, ten Firers and two Reserves; a total of 17 team members. Two reserves are included in the 17, who shall count as part of the team, and may assist the team in any capacity at the firing point, excepting Captaincy, coaching or firing, i.e. reserves may spot, plot,



score, check score etc. If one of the other team members falls ill and is unable to continue, a reserve may take his/her place.

## **5.6 DISTANCES**

Shot over 300, 600, 900 and 1000 yds or 300, 600, 800 and 900m. Combinations of imperial and metric distances are permitted if the range is configured as such, eg Connaught range in Canada.

## **5.7 NUMBER OF SHOTS**

Each firing member of the team shall fire two sighting shots (convertible) and ten shots to count at each distance.

## **5.8 SIGHTING SHOTS**

Two sighting shots, of which the second or both may be converted, are permitted at each distance. If shooting is interrupted for any team or teams by any external cause for not less than 3 minutes, the firer or firers so interrupted shall, on resuming, be allowed one sighting shot which may be converted to a counting shot. In the event of a rifle being changed a further sighting shot is not permitted.

## **5.9 AMMUNITION**

As per rules of ICFRA for the WLR Championship; Cost to each country competing.

## **5.10 TIME LIMITS**

300yds/300m 1 hour 15 minutes; 600yds/600m 1 hour 40 minutes; 900yds/800m; 1000yds/900m. If firing is interrupted by any external cause for not less than 3 minutes, Team Captains may request a corresponding extension of time.

## **5.11 RIFLES**

As per the rules of ICFRA for the WLR Championship

## **5.12 EAGLE EYE**

As per ICFRA Rules

## **5.13 RIFLE CHECKING**

All rifles intended to be used by teams in the Match shall be checked by the Match Executive Officer (or sometimes referred to as the "Match Director"] and Chief Range Officer, for conformation with the rules prior to the commencement of firing the first range. Rifles which conform to the rules shall have a sticker attached to so indicate. Random checks of rifles may be carried out during the course of the Match.

## **5.14 SHOOTING POSITION**

Prone.

## **5.15 TARGETS**

Two targets shall be available to each team and shall conform to the rules of the host National Rifle Association for each distance shot.

## **5.16 BUTTS OBSERVER**

Each team shall be entitled to one observer at the target butts. Teams shall provide such observer if required, but team members, including reserves, shall not be eligible.

## **5.17 SCORING**

Each team shall be responsible for providing two scorers, and two check scorers at the firing point. Team members including reserves, or volunteers from outside teams, may score or check score.

## **5.18 TIES**

Ties shall be decided in accordance with ICFRA rules for team competition.

## **5.19 DISPUTES**

Disputes (if any) shall be heard and decided by a disputes committee of 3 persons, consisting of the Match Executive Officer appointed by the Council of the NRA hosting the Match, the Chief Range Officer and one other.

## **5.20 TROPHIES**

ICFRA Gold Medals, seventeen (17), for the winning team shall be provided free of cost by the host country. Perpetual Trophy donated by the NRA of Australia.

## **5.21 SCORE CARDS**

ICFRA shall provide score cards. The host National Rifle Association shall forward copies of all score cards to the competing countries no later than two months after the conclusion of the Match.

## **5.22 GENERAL**

Any matter not provided for in these Rules and Conditions shall be decided upon at a meeting of Team Captains and Managers, and the Disputes Committee on the day prior to the Match being held.

## **5.23 ELIGIBILITY**

Provided a shooter holds a passport for the country he/she is to represent or has been a permanent resident in the country he/she is to represent for the two calendar years prior to the date of the match.

## **5.24 VARIATIONS TO RULES / CONDITIONS**

Variations to these Rules and Conditions may only be made by ICFRA.

## **6. JUNIOR AUSTRALIA MATCH**

### **6.1 DEFINITION**

To be held alongside any official Australia Match, provided only that range space is sufficient to accommodate the additional Junior teams. It may be held whenever two or more Under 25 teams are available to contest it, with the proviso that one of the competing teams must be an Australian Under 25 team. A country may field more than one team provided range space permits.

### **6.2 QUALIFICATION**

All members of the team, with the exception of Manager, must be under 25 years of age after the last day of the Junior Australia Match.

### **6.3 COMPOSITION**

Each team will comprise: Captain (who may also shoot), Wind-Coach (who does not shoot), Five shooters and one permitted reserve. Manager (who need not be under 25)

### **6.4 SELECTION PROCEDURES**

If selection is necessary from a touring team, it will be made by team management using current performance data. If the match is to be contested by dedicated arrangement the team will be selected as per current Selection Policy. Refer to Section 7 for further details.

### **6.5 TROPHIES**

ICFRA Gold medals to the winning team only. Perpetual Trophy donated by the NRA of Australia.

### **6.6 OTHER**

All other conditions as per the Australia Match

## 7. OFFICIAL AUSTRALIAN TEAMS

### 7.1 DEFINITION

Official Australian Teams will be sanctioned and administered by the NRAA Limited and shall be representative of the best possible markspersons available from within the States and Territories of Australia.

### 7.2 COMPETITIONS

Invitations received or extended by the NRAA to contest international events will be considered on their merits, with due notice given and within funding budgets, will view favourable all international competition. When travelling to other countries the NRAA will extend an offer to contest the Australia Match during the programme.

### 7.3 SELECTION PROCEDURES

The current NRAA policy of team selection will prevail. The Board will select the Captain. The selection Panel will consist of: The Captain, NRAA Competition Director and one other, appointed by the Board. Where a possible conflict of interest exists with NRAA Competition Director, the Board may call for nominations for and/or appoint an alternative selector. The Selection Panel will base their selections for the team on, but not limited to, performances that can include trials, interviews, past Oceania, Trans Tasman, National Teams, State Teams, Queens and Australia Cup results. The Selection Panel will submit their recommendations to the Board for formal ratification prior to making any announcements.

### AGE

Where an age restriction is specified for a competition, the following applies:

- U21: A Competitor will be deemed to qualify for an Australian U 21 team, if their 21<sup>st</sup> birthday falls after the last day of the relevant match.
- U25: A Competitor will be deemed to qualify for an Australian U 25 team, if their 25th birthday falls after the last day of the relevant match.
- Veteran: A Competitor must be 60yrs of age on or before the first day of competition as per ICFRA rules.
- Super Veteran: A Competitor who must be 70yrs of age on or before the first day of competition as per ICFRA rules.

### 7.4 TEAM CAPTAINS

The shooting Team Captain will take full responsibility for the competitive performance of the appointed team. The Captain shall be a competent shooter and tactician and worthy of respect from Australia's elite performers. Immediately after appointment the Captain will submit to the NRAA for approval a training and preparation programme, complete with a request for any special support i.e. technical, coaching, financial.

Within two months after the conclusion of the Match, the Captain shall submit a report detailing the Team's performance with recommendations for consideration by the Board for future teams.

### 7.5 TEAM MANAGERS

A Manager is responsible for the logistical support of the team and should be competent in the areas of administration, travel, finance, sponsorship and international protocol. The Manager will assist the Captain to prepare a travel programme and financial budget. Within a period of two months after the conclusion of the Match, the Manager shall submit a statement of accounts detailing how grants and other team funds were expended.

## 7.6 UNIFORMS

All sanctioned Australian Teams will wear the official NRAA uniform with the NRAA logo. Use of the Green blazer with the Australian Coat of Arms is restricted to the open Australian Team in the Palma and Australia matches only. The NRAA will provide, free of cost, a blazer pocket, tie and hatband to a shooter who makes the team for the first time. All other costs of uniforms shall be borne by the team members. If teams are supplied with other items of clothing by the NRAA, then the costs of these may be deducted from funding amounts due to each member.

All members of official Australian teams shall be required to wear a blazer with an embroidered pocket. Formal uniform dress ("No 1s") for males, shall be blazer, long sleeve white business shirt and current NRAA tie. The colour of trousers and shoes may be varied by the Team Captain, subject to approval of the Board.

Female members shall also wear the official blazer with an ensemble of blouse/skirt/trousers to the approval of the Captain.

Teams may choose an informal uniform dress ("No 2s") of optional 'polo' shirts and/or track suit-type jackets, but are to liaise with the NRAA in order to standardise on designs.

## 7.7 TEAM FUNCTIONS

Teams will arrange to be represented at all functions and ceremonies for which invitations have been received. The Captain and Manager will determine which level of representation is required to satisfy the expectations of the host.

## 7.8 GUIDELINES FOR CAPTAINS

Contact team members after selection and obtain details of their equipment, especially check (in co-operation with the team armourer) on barrel requirements for the ammunition to be used on tour. Utilise past Captains experience. Organise, in co-operation with the teams training coach (if applicable), training programmes and practice sessions. If Matches which include 1000yds are to be fired on tour eg Palma and Australia Match, concentrate practice at that distance.

Discuss itinerary with Manager and arrange as much practice on arrival as possible. Try to arrange to arrive a few days before shooting starts to help shooters overcome the effects of jet lag. Talk to previous captains and/or members of previous teams to the venue you are going to, to find out any possible problems that might occur.

## 7.9 GUIDELINES FOR MANAGERS

Contact the Captain as soon as possible after team appointments have been made. Contact team members and ascertain those that need Australian blazers etc. Uniforms: Arrange team giveaways and gifts for opposing Captains and host country officials. Ensure you have enough, something Australian and suitably engraved. Contact Customs at your port of arrival and advise of your arrival flight number and time of arrival and enquire if any special documentation is required. Take their response letter with you it can be a great help when you arrive and a customs officer becomes difficult.

For Bisley teams, contact NRAGB for information re Surrey Police permits. Advise team members to obtain the necessary Australian customs forms and have them stamped at their nearest customs office. Ensure all team members have their State Firearms License with them. Arrange in co-operation with the team armourer for a supply of spare parts etc.



Liaise with Captain and travel agent re itinerary etc. Allow as much time as possible to overcome the affects of jet lag after arrival at your destination. Arrange for accommodation at the shooting venue well in advance. Seek sponsorship wherever possible. Raffle donated prizes - seek holiday from airlines? Etc

Be prepared to travel a day or two in advance of the main group to ensure all arrangements are in hand before the party gets there. Be conversant with all travel arrangements, and reconfirm all flights, bus transport and accommodation well beforehand. Seek out other past Managers for any information you may need.

## 8. AUSTRALIAN UNDER 25 TEAMS

### 8.1 DEFINITION

Under 25 Teams along with Ladies and Veterans Teams are specialist teams and are encouraged in order to generate and maintain a high level of competitiveness and foster international relations across a broad base of our shooting population.

### 8.2 COMPETITIONS

Competitions can vary to suit the circumstances, although they are usually restricted to a maximum of 10 scoring shots each at 300, 600, 900, 1000 yards or their metric equivalent. Matches will be contested in Australia at the request of any visiting country.

### 8.3 TEAM COMPOSITION

Team Composition may vary depending on the conditions of the match and host country variations. A Competitor will be deemed to qualify for an Australian U 25 team, if their 25th birthday falls after the last day of the relevant match.

### 8.4 FUNDING

Current policy is all teams are self funding other than special grants received for specific matches.

### 8.5 UNIFORMS

All sanctioned Australian Teams will wear the official NRAA uniform with the NRAA logo. The NRAA will provide free of cost a blazer pocket, tie and hatband to a shooter who makes the team for the first time. All other costs of uniforms shall be borne by the team members. If teams are supplied with other items of clothing by the NRAA, then the costs of these may be deducted from funding amounts due to each member.

All members of official Australian teams shall be required to wear a blazer with an embroidered pocket. Formal uniform dress ("No 1s") for males, shall be blazer, long sleeve white business shirt and current NRAA tie. Competitions can vary to suit the circumstances, although they are usually restricted to a maximum of 20 scoring shots each at 300, 600, 900, 1000 yards or their metric equivalent. Matches will be contested in Australia at the request of any visiting country.

### 9.3 TEAM COMPOSITION

Team Composition may vary depending on the conditions of the match and host country variations.

### 9.4 FUNDING

Current policy is all teams are self funding other than special grants received for specific matches.

### 9.5 UNIFORMS

All sanctioned Australian Teams will wear the official NRAA uniform with the NRAA logo. The NRAA will provide free of cost a blazer pocket, tie and hatband to a shooter who makes the team for the first time. All other costs of uniforms shall be borne by the team members. Four (4) Firers; One [1] Reserve; One [1] Wind Coach (can shoot if required); One [1] Captain/Manager [may be over 21/25 but takes no part on the mound]. Total Team composition: seven [7]

[Note that the composition of the teams must be clarified prior to each match. New Zealand advised that the composition of the teams for the 2008 matches were:

Five (5) Firers; One [1] Reserve; One [1] Wind Coach (may be over 21/25); One [1] Captain [may be over 21/25].  
One [1] Manager [may be over 21/25 but takes no part on the mound]. Total Team composition: seven [9]

#### Age

A firer will be deemed to qualify for the team if their 21<sup>st</sup> or 25<sup>th</sup> birthday (as the case may be) falls after the last day of competition.

### **14.5 ELIGIBILITY**

Eligibility rules apply to World Championships and other events, invitations may need to be sought to attend some events.

### **14.6 ANTI DOPING RULES**

Strict anti doping rules apply, it is strongly advised that any person intending to compete at World Championships & World Cup level be aware of the published lists of drugs that are on the ISSF & IOC anti doping lists.

### **14.7 TEAM MEMBERSHIP**

Team membership for international teams is as a part of a Shooting Australia team and the team members will be responsible to not only their section leader but also to the overall team General Manager. All competitors must have an ISSF Registration Number.

### **14.8 UNIFORMS & PROTOCOL**

International Protocol standards have to be maintained with respect to behaviour and official attendance at functions, dress rules apply at official functions and medal presentations, official uniform as prescribed by Shooting Australia to be worn, other times neat casual wear or track suits, on the range normal shooting dress.

### **14.9 GENERAL**

All 300m shooting is conducted under the ISSF Rules which are in force for 4 years with any amendments being published in the ISSF Journal.

## 15. MATCH RIFLE - WOOMERA INTERNATIONAL TEAMS

### 15.1 TEAM COMPOSITION

Each National team comprises sixteen (16) members inclusive of a Captain and Manager. Only eight (8) members may shoot at each distance, divided into two (2) squads of four (4) shooters each. Any or all of the sixteen team members may coach.

### 15.2 RANGES

The competition is held over 1000, 1100 and 1200 yards with each shooter firing two (2) optional sighters and fifteen (15) counting shots

### 15.3 CONDITIONS

Currently only Australia and Great Britain compete in this match but the competition is open to other National teams. The Aggregate for the Woomera International Team Trophy shall consist of all 24 scores recorded. The competition is conducted under the Standard Shooting Rules of the host country for the event. In the event that a shooting team member is affected by illness or accident to the extent that they are unable to continue shooting, they may, subject to approval by the Match Executive Officer, be replaced by another non shooting team member who may take over from the shooter replaced, and continue as if they were the original team member.

Non team members are permitted to score and check score.

### 15.4 TIME LIMITS

The time limit shall be 100 minutes for the eight shooters (2 squads of four) at each distance.

### 15.5 MEDALS

- NRAA Perpetual Trophy (which remains in Australia)
- 16 x AMRA Silver Medals to the 2<sup>nd</sup> placed team.
- 16 x NRAA Gold Medals to the winning team

### 15.6 UNIFORM

The Australian Team Uniform will be as per the NRAA Uniform Code or as directed by the NRAA

### 15.7 SELECTION POLICY

The Captain of the Australian Team will be selected by the NRAA Board.

A Selection Panel consisting of the Captain, NRAA Competition Director and One other, as appointed by the NRAA Competition Director, will comprise the team Selection Panel.

The Selection Panel will base their selections for the team on, but not limited to, performances that can include State and National Match Rifle team performances, individual Match Rifle performances at State, National or International competitions and/or representative performances in other disciplines.



## 16. HOST ASSOCIATION RESPONSIBILITIES

### 16.1 APPLICATION

This section applies to any NRAA event that held away from the NRAA Range.

### 16.2 MARKERS

Where manual targets are used, the Host Association will provide sufficient markers which must be available on practice and match days.

### 16.3 TARGETS

The Host State will provide sufficient targets with new faces and there should be spare targets as back up in case of breakage or other damage.

### 16.4 RANGE STAFF

The NRAA will appoint a Match Executive Officer (MEO) and Chief Range Officer (CRO), whilst the host state should provide all other range staff.

### 16.5 PRECEDENCE

In all cases where a state is hosting an international event, eg, Ladies or Veterans, precedence to the international event must always be given over any local or national events with respect to targets and range allocation.

### 16.6 RANGE FLAGS

The range should be flagged to a standard acceptable to the MEO.

### 16.7 OTHER

Primarily the NRAA, in consultation with the Competition Director, will disseminate all programs and information on the event. The NRAA EO will usually co-ordinate and supply statistics, awards, and liaise with the local Association who shall arrange the dinner venue and all associated matters. The host state will also arrange all on range matters – targets, range staff etc. Provide a suitable stats facility for the NRAA to work from.

## 17. NATIONAL TEAMS MATCHES – OPEN

### 17.1 GENERAL

The Open State and Territory Teams events are designed to encourage competition between the States and Territories at the highest possible level.

### 17.2 BRIEF HISTORY

The Commonwealth Teams Matches were first held in 1926 for the Cheylesmore Memorial Cup which was named after Major General Herbert Francis Eaton Cheylesmore KCMG, KCVG, CBE (Chairman of the NRAGB 1903-1925) and renamed the Sir Charles Merrett Match in 1948.

### 17.3 SELECTION PROCEDURE

Selection of these teams is the responsibility of the respective states or territories.

### 17.4 ELIGIBILITY

Each State and Territory Association is eligible to enter one team. Where two or more States and Territories are unable to field their own teams, a composite team(s) may be permitted to enter subject to approval by the NRAA. Team members shall be affiliated members of the NRAA and primary bona fide members of the State or Territory Rifle Association, which they will represent as at the date on which selection to the team is confirmed. A team shall not number more than 14 active participants from whom shall be selected the numbers required for each match as set down in the conditions. A team may appoint a Manager to make a total of 15 team members.

### 17.5 VICE CAPTAIN

In the event that the Captain of the team is not available to fulfil his/her duties then he/she may appoint a vice captain who for the period of appointment is deemed in all respects to be the Captain.

### 17.6 AWARDS

Perpetual Team Trophies for the Merrett, Bruce White, Denzil MacArthur Onslow, The Neville Holt, Alastair Macpherson. The Sweet Perpetual Trophy for the team with the highest aggregate score of the five individual matches. The R & J McGowan Trophy to be awarded to the team with the highest aggregate in the Bruce White and Denzil MacArthur-Onslow matches. The Gordon Highlanders Trophy to be awarded to the team with the highest aggregate in the Alastair Macpherson and Neville Holt. The Presidents Trophy awarded to the highest top off rifle individual score in the Merrett Match. Gold Medals shall be awarded to each member (including reserve and Manager) of the first place team of the Merrett Match and the Sweet only. Such medals to be provided by the NRAA Limited but the host State Association shall be responsible for the costs thereof.

### 17.7 CONTROL

The matches will be under the control of a Match EO representing the NRAA.

## 17.8 SQUADDING

The CRO shall conduct a draw for targets each morning and after every major break in the program when the markers leave the butts. For the purpose of increasing spectator interest, at the final range of the Merrett Match and The Sweet, the CRO shall squad the leading team in the centre of the range with the remaining teams allocated adjacent to and alternating each side of the leading team in descending order of their placing prior to the final range.

## 17.9 SAFETY

The Captain of each competing team will be responsible for ensuring that each member of the team strictly observes Standard Shooting Rules (SSRs) in their entirety.

## 17.10 AMMUNITION

NRAA approved loaded factory ammunition and handloads are permitted.

## 17.11 COSTS

The host State shall calculate all local costs incurred in staging the matches, including markers, range and butts officers, targets, and target materials, range fees etc (but not including ammunition costs) and shall submit these detailed costs to the NRAA. The NRAA shall include any other costs that may be involved in running the event and then submit a Budget for the event to the NRAA Board. Upon approval the NRAA shall strike a Teams Entry Fee payable by each State.

Every effort should be made to keep these costs to a minimum and host States should keep in mind the benefits that accrue from having the match held at their venue

## 17.12 MEETING

A meeting chaired by the Match EO and attended by the CRO and one representative from each competing team shall be held, where practicable, on the day prior to the conduct of practice shooting. The purpose of such meeting shall be to explain practice and Match Conditions as prescribed herein, to decide on practice times and to discuss any local issues which may impact on the conduct of the practices or matches. In all matters the decision of the Match EO shall be final.

## 17.13 CHALLENGES

Any challenges shall be as per SSR's.

## 17.14 EVENTS

The National Teams is currently conducted by rotation of the States & Territories on an approximate 18 month to 24 months cycle. Any consideration for a rotation change shall be determined by the Board.



## **17.15 SIR CHARLES MERRETT MATCH [Match 1]**

### **TEAM COMPOSITION**

The minimum entry is 3 teams. Ten (10) shooting members, One (1) shooting Reserve, One (1) Master coach, Two (2) coaches, One (1) Manager, One (1) Captain

### **RANGES**

Where the venue allows, the match shall be conducted over;300, 600, 900, 1000 yards or metric equivalent. In the event the venue does not allow the above the match shall be conducted over 300, 600, 700, 900yds or metric equivalent.

### **SHOTS**

There will be Two (2) optional sighters and Ten (10) scoring shots per shooter to count at each distance.

### **TIME LIMITS**

300yds/m	1 hour 15 minutes;	600yds/m	1 hour 15 minutes;
700yds/m	1 hour 15 minutes;	900yds/800m	1 hour 30 minutes;
1000yds/900m	1 hour 30 minutes.		

### **ON MOUND PERSONNEL**

Ten shooting members; one master coach ,two coaches; one Captain; two scorers (not required to be team members), two check scorers who need not be members of any of the teams competing.

### **AWARDS**

NRAA Gold medals and the Sir Charles Merrett Perpetual Trophy shall be awarded to the winning team.

### **TARGETS**

Two (2) targets per team.

## 17.16 THE BRUCE WHITE MEMORIAL MATCH [Match 2]

### TEAM COMPOSITION

The minimum entry is 3 teams. Five (5) shooting members\*, One (1) shooting Reserve, One (1) coach\*, One (1) Manager, One (1) Captain. Note: \* Only one member of this team is eligible to contest the long range match, but in a different role, ie a shooter in the short range match can coach in the long range match or a coach in the short range match can shoot in the long range match.

### RANGES

The distance is 300yds or metric equivalent.

### SHOTS

There shall be Two (2) optional sighters and Fifteen (15) scoring shots per shooter to count.

### TIME LIMITS

1 hour 30 minutes.

### ON MOUND PERSONNEL

Five shooting members; one coach; one Captain; one scorer (not required to be team members), one check scorer, who need not be members of any of the teams competing.

### AWARDS

Bruce White Perpetual Team trophy.

### TARGETS

One (1) target per team.

## 17.17 SIR DENZIL MACARTHUR ONSLOW MEMORIAL MATCH [Match 3]

### TEAM COMPOSITION

The minimum entry is 3 teams. Five (5) shooting members\*, One (1) shooting Reserve, One (1) coach\*, One (1) Manager, One (1) Captain. Note: \* Only one member of this team is eligible to contest the short range match, but in a different role, ie a shooter in the long range match can coach in the short range match or a coach in the long range match can shoot in the short range match.

### RANGES

The distance is 900yds or metric equivalent.

### SHOTS

There shall be Two (2) optional sighters and Fifteen (15) scoring shots per shooter to count.

### TIME LIMITS

1 hour 45 minutes.

### CHALLENGES

As per SSR's.



### **ON MOUND PERSONNEL**

Five shooting members; one coach; one Captain; one scorer (not required to be team members), one check scorer, who need not be members of any of the teams competing.

### **AWARDS**

Denzil MacArthur-Onslow Perpetual Team trophy

### **TARGETS**

One (1) target per team

## **17.18 THE ALASTAIR MACPHERSON MATCH [Match 4]**

### **TEAM COMPOSITION**

The minimum entry is 3 teams. Ten (10) shooting members, One (1) shooting Reserve, One (1) Master Coach, Two (2) coaches, One (1) Manager, One (1) Captain.

### **RANGES**

600yds or metric equivalent will be shot.

### **SHOTS**

There shall be Two (2) optional sighters and Ten (10) scoring shots per shooter to count.

### **TIME LIMITS**

600yds - 1 hour 15 minutes

### **ON MOUND PERSONNEL**

Ten shooting members; one master coach, two coaches; one Captain; two scorers (not required to be team members), two check scorers who need not be members of any of the teams competing.

### **AWARDS**

Northcote Perpetual Team Trophy.

### **TARGETS**

Two (2) targets per team.



## **17.19 THE NEVILLE HOLT MATCH [Match 5]**

### **TEAM COMPOSITION**

The minimum entry is 3 teams. Ten (10) shooting members and One (1) shooting Reserve. One (1) Master Coach, two (2) coaches, One (1) Manager, One (1) Captain.

### **RANGES**

Where the venue allowed 300,600,900,1000yds competition, this match will be conducted over 1000yds or metric equivalent; If the venue does not allow for the above ranges; 900yds or 800m will be shot

### **SHOTS**

Two (2) optional sighters and Ten (10) scoring shots per shooter to count

### **TIME LIMITS**

1 hour 30 minutes.

### **ON MOUND PERSONNEL**

Ten shooting members; one master coach, two coaches; one Captain; two scorers, (not required to be team members), two check scorers who need not be members of any of the team competing.

### **AWARDS**

Ferg Beattie Perpetual Trophy.

### **TARGETS**

Two (2) targets per team.

## **17.20 SHORT & LONG RANGE MATCH AGGREGATE [Match 6]**

### **Aggregate**

Aggregates of Match 2 and Match 3.

### **Award**

R & J McGowan Perpetual Team Trophy.

## **17.21 A W HAMMETT AGGREGATE [Match 7]**

## 18. NATIONAL TEAMS MATCHES – Under 25

### 18.1 GENERAL

The U25 State and Territory Teams events are designed to encourage competition between the States and Territories at the highest possible level.

### 18.2 BRIEF HISTORY

The Under 25 teams competitions were first conducted in 1978 in Adelaide.

### 18.3 SELECTION PROCEDURE

Selection of these teams is the responsibility of the respective states or territories.

### 18.4 ELIGIBILITY

One team from each State and Territory Association and from each of the three Armed Services. Other teams may be invited by NRAA. Team members shall be affiliated members of the NRAA and primary bona fide members of the State or Territory Rifle Association, which they will represent as at the date on which selection to the team is confirmed. A team shall number not more than Eight [8] active participants from whom shall be selected the number required for each match as set down in the conditions. A team will comprise a Manager who may be over 25, but who has no function on the mound; a Captain / Coach who may be over 25; Firers: Five [5] and One [1] reserve who must be U25 at the commencement of competition.

### AGE

A Competitor will be deemed to qualify if their 25th birthday falls after the last day of the relevant NRAA event.

### 18.5 ON MOUND PERSONNEL

Five shooting members; one coach/Captain; one optional plotter (who may be a shooting member or reserve); one scorer (not required to be a team member), one check scorer who need not be a member of any of the teams competing.

### 18.6 COMPOSITE TEAMS

Those States and Territory Associations unable to field a team because of numbers are permitted to pass on to the NRAA any nominations received for a President Teams and be forwarded to the NRAA three (3) months prior to the event. Those States and Territory who are able to field a team and who have additional nominations may submit those additional nominations for selection in President Teams within three (3) months before the event. The President Teams are eligible for all trophies and awards. Members of the President Teams shall be entitled to wear an NRAA tie and name badge, supplied by the NRAA. A Captain/Manager will be appointed by the President from any Association.

### 18.7 VICE CAPTAIN

In the event that the Captain of the team is not available to fulfil his/her duties then he/she may appoint a Vice Captain who for the period of appointment is deemed in all respects to be the Captain.

## 18.8 RANGES

These matches will be conducted under the same conditions and at the same venue as for the Senior Teams with the exception of team numbers.

## 18.9 AWARDS

Gold Medals shall be awarded to each member (including reserve and manager) of the first place team of the West Australia and the Moss Match only. Such medals to be provided by the NRAA Limited, but the host State Association shall be responsible for the costs thereof.

## 18.12 SAFETY

The Captain of each competing team will be responsible for ensuring that each member of the team strictly observes Standard Shooting Rules (SSR's) in their entirety.

## 18.13 AMMUNITION

NRAA approved loaded factory ammunition and hand loads are permitted.

## 18.14 COSTS

All local costs incurred in staging the matches, including markers, range and butts officers, targets, and target materials, range fees etc (but not including ammunition costs) shall be the responsibility of the host State Association. To help defray these costs a host State Association may impose entry fees for competing teams, but the amount of such entry fees shall be approved by the NRAA Limited at the time that approval is granted to the applicant State Association to host the matches.

## 18.15 MEETING

A meeting chaired by the Match EO and attended by the CRO and one representative from each competing team shall be held, where practicable, on the day prior to the conduct of practice shooting. The purpose of such meeting shall be to explain practice and match conditions prescribed herein, to decide on practice times and to discuss any local issues which may impact on the conduct of the practices or matches. The decision of the Match EO shall be final.

## 19. NATIONAL TEAMS MATCHES – F Class

### 19.1 GENERAL

The Open State and Territory F Class Standard, F Open and F T/R Team's events are designed to encourage competition between the States and Territories at the highest possible level.

### 19.2 SELECTION PROCEDURE

Selection of these teams is the responsibility of the respective States or Territories. They shall call for nominations and are responsible for whatever selection process and procedures are used.

### 19.3 ELIGIBILITY

Matches are open to F Standard, F Open and F /TR Disciplines and the following conditions apply.

Each State and Territory Association is eligible to enter one team in each Discipline. Where two or more States and Territories are unable to field their own teams, a composite team(s) may be permitted to enter subject to approval by the NRAA. Team members shall be affiliated members of the NRAA and primary bona fide members of the State or Territory Rifle Association, which they will represent as at the date on which selection to the team is confirmed. A team shall not number more than 9 active participants from whom shall be selected the numbers required for each match as set down in the Match Conditions. A team will consist of a Captain, six shooters, a reserve shooter and a main Wind Coach. From this group of nine, the team may nominate a second wind coach to assist, to read mirage or to rotate with the other Wind Coach to directly coach up to three shooters. Where teams have less than nine members, the minimum number of shooters is six and team members may carry out dual roles as captain, shooter and coach.

An Association if it so desires may appoint in addition to the 9 team members a Team Manager who shall not take an active part in assisting the Team on the shooting mound other than recording the scores of the team on the official scorecard. Team Captain and Team Coach may also be shooting members of the team if a team so decides, but the actual team make up shall be made known to the NRAA Match Executive Officer, in writing, i.e. by entering the names of the team's shooters, the Team Captain, the Team Coach and the Team Reserve on the official score card, no later than 30 minutes prior to the commencement of any match. If in the opinion of the Match Executive Officer, a team member becomes unable to continue, the team reserve may act in any team capacity, i.e. the team reserve may Captain the team, may coach and/or shoot.

### 19.4 VICE CAPTAIN

In the event that the Captain of the team is not available to fulfil his/her duties then he/she may appoint a vice captain who for the period of appointment is deemed in all respects to be the Captain.

### 19.5 AWARDS

Perpetual team trophies will be awarded for each match and each Discipline.

Gold Medallions (10) shall be awarded to each member (including Manager) of the First placed teams in Matches 2 and 3. The assigned Trophies will be awarded to the highest top off rifle individual score in Match 4 for each Discipline, as well as Gold Medals for each of these individuals and their respective coach. Such medals to be provided by the NRAA Limited and costs included in Team Entries.

## **19.6 CONTROL**

The matches will be under the control of a Match EO representing the NRAA.

## **19.7 SQUADDING**

The CRO shall conduct a draw for targets each morning and after every major break in the program when the markers leave the butts. For the purpose of increasing spectator interest, at the final range of the CRO shall squad the leading team in the centre of the range with the remaining teams allocated adjacent to and alternating each side of the leading team in descending order of their placing prior to the final range.

## **19.8 SAFETY**

The Captain of each competing team will be responsible for ensuring that each member of the team strictly observes Standard Shooting Rules (SSRs) in their entirety.

## **19.9 AMMUNITION**

NRAA approved loaded factory ammunition and handloads are permitted.

## **19.10 COSTS**

The host State shall calculate all local costs incurred in staging the matches, including markers, range and butts officers, targets, and target materials, range fees etc (but not including ammunition costs) and shall submit these detailed costs to the NRAA. The NRAA shall include any other costs that may be involved in running the event and then submit a Budget for the event to the NRAA Board. Upon approval the NRAA shall strike a Teams Entry Fee payable by each State.

Every effort should be made to keep these costs to a minimum and host States should keep in mind the benefits that accrue from having the match held at their venue.

## **19.11 PRE-MATCH MEETING**

A meeting chaired by the Match EO and attended by the CRO and one representative from each competing team shall be held, where practicable, on the day prior to the conduct of practice shooting. The purpose of such meeting shall be to explain the Practice and Match Conditions as prescribed herein, to decide on Practice times and to discuss any local issues which may impact on the conduct of the practices or matches. In all matters the decision of the Match EO shall be final.

## **19.12 CHALLENGES**

Any challenges shall be as per SSR's.

## **19.13 EVENTS**

National Teams Matches are currently conducted by rotation of the States & Territories. Final Decisions on venues and dates will be made by the NRAA Board.

## **19.14 TIME LIMITS**

Time limits per Range have been calculated as per ICFRA Rules. Should any Range be completed before time, the next Range may commence early, subject to agreement between all Team Captains and at the discretion of the CRO.



## 19.15 MEDALLIONS & TROPHIES

Medallions will be awarded to First Placed teams and for Matches 2 & 3. Also see the Provisions for Individual medallions in Match 4. All other matches have Perpetual Trophies or Shields only.

Below are the formats for various Matches and Awards as decided by the NRAA as at August 2023:

## 19.16 GENERAL FORMAT - 3 days of matches

Day 1 – Practice sessions at 800/900/1000yds or 700/800/900m.

Day 2 – Match 1 - 15 shots at 900yds or 800m. 20 shots at 1000yds or 900m.

Day 3 – Match 2 - 15 shots at 800/900/1000yds or 700m/800m/900m.

If a Venue has distance or target limitations, then the above course of fire may be modified on approval of the NRAA. Separate details may be conducted provided that all teams of the same discipline shoot in the same detail, eg. detail 1 for FS, detail 2 for FO, detail 3 for F/TR.

Matches will be shot under the current NRAA SSR's. Time limits have been calculated as per ICFRA Rules.

**19.17 QLD Long Range F STANDARD MATCH – 2 ranges [Match 1]**

**19.18 SARA Long Range F OPEN MATCH – 2 ranges [Match 1]**

**19.19 NQRA Long Range F/TR MATCH – 2 ranges [Match 1]**

## 19.20 TEAM COMPOSITION

The minimum entry for the event will be 3 teams. One (1) Captain, One (1) Coach, Six (6) shooting members, One (1) shooting Reserve, One (1) Manager.

## 19.21 RANGES

The distance is 900yds or 800m and followed by 1000yds or metric equivalent which is 900 metres.

## 19.22 SHOTS

There shall be Two (2) optional sighters and either Fifteen (15) or Twenty (20) scoring shots per shooter to count as Per programme.

## 19.23 TIME LIMITS

For 15 shot Matches with 2 sighters the time limit for each range is 2 Hrs-8 Mins (as Per ICFRA Time Limits).

For 20 shot Matches with 2 sighters the time limit for each range is 2Hrs-45 Mins (as Per ICFRA Time Limits).

## 19.24 ON MOUND PERSONNEL

Six shooting members; two Coaches; one Captain; one scorer (not required to be team member), one check scorer, (who need not be member of any of the teams competing.)

### 19.25 AWARDS

The assigned Perpetual Team Trophies only. No Medallions.

### 19.31 RANGES

Where the venue allows, the match shall be conducted over 800, 900, 1000 yards or metric equivalent which is 700, 800 and 900 metres.

### 19.32 SHOTS

There will be Two (2) optional sighters and Fifteen (15) scoring shots per shooter to count at each distance.

### 19.33 TIME LIMITS

For 15 shot Matches with 2 sighters the time limit for each range is 2 Hrs-8 Mins (as Per ICFRA Time Limits).

### 19.34 ON MOUND PERSONNEL

Six shooting members; two Coaches; one Captain; one scorer (not required to be team member), one check scorer (who need not be a member of any of the teams competing).

### 19.35 AWARDS

The assigned Perpetual Team trophy for each winning team, with the NRAA supplying Gold Medallions for the members of the First Placed Team only.

## 20. LADIES STATE & TERRITORY TEAMS MATCHES

### 20.1 DEFINITION

Teams of women from the States and Territories.

### 20.2 BRIEF HISTORY

The Ladies competitions were first conducted in Melbourne 1968. In 2019 the Australian Rifle Women held their AGM and voted to change the Ladies Teams Matches to include F Class Shooters. At this meeting the "Medlands Trophy" was retired to be displayed in the NRAA museum.

### 20.3 TEAM COMPOSITION

Teams consist of a Captain, Coach, five shooters, reserve to a total of (8). This can comprise of any number in Target Rifle, F Open, F Standard or FTR.

### 20.4 SELECTION PROCEDURE

Selection of these teams will be called for and is the responsibility of the respective States and Territories. Upon application and approval from the NRAA shooters from any States or Territories not already represented may combine to form a team and will be eligible to win all competition trophies.

### 20.5 ELIGIBILITY

All NRAA affiliated members are eligible to nominate for their Association teams. A minimum of three teams must compete otherwise the matches shall be cancelled. Each Association may enter Two. All team members including Manager must be female.

### 20.6 VENUE

NRAA Headquarters Range or as otherwise arranged by NRAA, the current program being:

### 20.7 TEAM MAKE UP

A team shall not number more than 8 active participants of any stated discipline from whom shall be selected the numbers required for each match as set down in the Match Conditions. An Association if it so desires may appoint in addition to the 8 team members a Team Manager who shall not take an active part in assisting the Team on the shooting mound other than recording the scores of the team on the official scorecard. Team Captain and Team Coach may also be shooting members of the team if a team so decides, but the actual team make up shall be made known to the NRAA Match Executive Officer, in writing, i.e. by entering the names of the team's shooters, the Team Captain, the Team Coach and the Team Reserve on the official score card, no later than 30 minutes prior to the commencement of any match. If in the opinion of the Match Executive Officer, a team member becomes unable to continue, the team reserve may act in any team capacity (other than Manager) i.e. team reserve may Captain the team, may coach and/or shoot.

## 20.8 SCORING SYSTEM

The MCSI system or any other approved “mixed” scoring system will be used for the competition. The Executive of the Association to confirm the scoring system 3 months prior to the commencement of the Matches.

## 20.9 AMMUNITION

Each team shall be responsible for its own ammunition costs. Ammunition as allowed in SSR's shall be used.

## 20.10 SAFETY

The Captain of each competing team will be responsible for ensuring that each member of the team strictly observes Standard Shooting Rules (SSR's) in their entirety.

## 20.11 CONTROL

The overall programming and control of all matches and practices and the hearing and deciding of all protests and appeals shall be the responsibility of the Match Executive Officer appointed by and representing the NRAA Limited. In addition, if the NCRO is not available, the NRAA Limited shall appoint upon recommendation from the host Association, a CRO, who shall be responsible for the conduct of matches at the firing point. The Match Executive Officer and the CRO shall not be the same person.

## 20.12 SCORING AND CHECK SCORING

Each team shall provide, from amongst its own team members, or from members of the same Association, one scorer, who shall record scores on the team's official scorecard. Each team shall provide, from amongst its own team members, or from members of the same Association, one check scorer who shall check score for an opposing team.

## 20.13 MEDALS AND AWARDS

Gold medals shall be awarded to each of the first placed team of the **Shepherd Match** and the Geraldine Davis Match [9]. Such medals shall be provided by the NRAA Limited, but the host Association shall be responsible for the costs thereof.

## 20.14 COSTS

All local costs incurred in staging the matches, including markers, range and butts officers, targets and target materials, range fees etc (but not including ammunition costs) shall be the responsibility of the host Association. To help defray these costs a host Association may impose entry fees for competing teams, but the amount of such entry fees shall be approved by the NRAA

## **20.15 CHALLENGES**

Challenges shall be permitted in accordance with SSR's

## **20.16 PRACTICE**

Where practicable, team practice shall be conducted on day one of the team shooting programme. The actual distances, starting times and duration of practices shall be decided at a meeting between the Match Executive Officer, the CRO and a representative from each competing team. (See 'Meeting' below) A non-shooting break of at least 30 minutes between the completion of any practice and the commencement of any match shall be observed. No practice shooting shall be permitted after the conclusion of the Presidents Match

## **20.17 THE GERALDINE DAVIS MATCH (former Presidents Match)**

### **TEAM COMPOSITION**

Five (5) shooting members One (1) team reserve One (1) coach One (1) captain One (1) manager any discipline defined above.

### **DISTANCE**

Where the range permits the match will be fired at 1000yds; if not then the match will be fired over 900 yards or 800 metres.

### **SHOTS**

Two (2) optional sighter Fifteen (15) counting shots per shooter

### **TARGETS**

One (1) per team.

### **TIME LIMITS**

1 hour 30 minutes; 900yds/800m 1 hour 45 minutes; 1000yds

### **ON MOUND PERSONNEL**

Five (5) shooting members One (1) Coach; One (1) Captain; One (1) Scorer provided by competing team (team reserve or manager eligible)

### **AWARD**

Gold Medal 1<sup>st</sup>

## 20.18 THE SHEPHERD MATCH (former Medlands Match)

### TEAM COMPOSITION

Five (5) shooting members One (1) team reserve One (1) coach One (1) captain One (1) manager of any discipline defined above

### DISTANCE

300,600,900, 1000 yds or metric equivalent

### SHOTS

Two (2) optional sighter Ten (10) counting shots per shooter at each distance

### TARGETS

One (1) per team

### TIME LIMITS

## 21. VETERANS NATIONAL TEAMS MATCHES

### 21.1 PRINCIPLE

All competitions will be conducted under the NRAA Standard Shooting Rules current at the time of the competition.

Subject to availability of a venue, the NRAA Board will preside over the National Veteran Teams Championships no more than once per calendar year.

#### **Hosting**

Each NRAA Member Rifle Association fielding a minimum of two teams, one of which must be Target Rifle, on two consecutive occasions will be eligible to host the National Veteran Teams Championships by rotation, noting that matches held in conjunction with the National Championships are also included in the rotation

When and where possible, the National Veteran Teams Championships will be held immediately prior to or immediately following a National or State/Territory Annual Open Championship.

### 21.2 ELIGIBILITY TO PARTICIPATE

All competitors taking part in events promoted by the NRAA must be financial members of the NRAA. The NRAA shall be entitled to recover the cost of such participation at the discretion of the Executive, including on-going administrative costs, range costs and the cost of trophies. Generally, a minimum of three States/Territories must enter a team in a discipline for a match to be valid and trophies and medals to be awarded.

#### **Age**

A competitor must be 60yrs of age on or before the first day of competition as per ICFRA rules.

### 21.3 COMPOSITION OF A TEAM

A State or Territory Association can field teams in the following disciplines:

- Target Rifle – Up to two teams
- F-Standard – One team
- F-Open – One Team
- FTR – One Team

For administrative purposes, each State and Territory shall nominate one Squad Captain to coordinate between their own teams. The Squad Captain is the primary point of contact from each State/Territory and shall attend the formal meeting with the NRAA Match Director and Range Officer. Individual Team Captains may attend to observe.

#### **Composite “President’s” Team**

Those States and Territory Associations unable to field teams due to not enough nominations being received, are permitted to pass on to the NRAA any nominations received. Nominations received will be considered for the forming of a President’s Team. Nominations should be forwarded no later than the date NRAA has advised for nominations of team entries to be received.

In addition, NRAA may also call for nominations directly from Veteran aged member shooters to be part of a President’s team in any or all of TR , FSTD, FO and F/TR. The President’s Team is eligible for all trophies and awards.



### **TR Teams**

A TR team representing a State or Territory Association at the National Veteran Teams Championships will consist of:

- A Wind Judge/Coach and five shooters, and may include a reserve, but in the event of a shortfall in numbers the Wind Judge/Coach may be appointed from the 5 team members.
- A Team Captain shall be appointed from within the team members to control the match activities on the mound, and may also shoot, coach or be a reserve.
- The total score obtained by all five shooters will be the TR team score for the match.
- Each State or Territory Association may enter one or two TR Teams whose personnel must be declared prior to the commencement of all competitions.

### **F Class Teams**

One F-Class team from each of F Standard, F Open and FTR disciplines are also able to be entered representing a State or Territory Association at the National Veteran Teams Championships and will consist of:

- A Wind Judge/Coach and five shooters, a Captain and may include a reserve, but in the event of a shortfall in numbers the Wind Judge/Coach may be appointed from the 5 team members.
- A Team Captain shall be appointed from within the team members to control the match activities on the mound, and may also shoot, coach or be a reserve. The total score obtained by all five shooters will be the F-Class discipline team score for the match.
- Each State or Territory Association may therefore enter up to two TR teams and three F-Class teams (three separate disciplines) whose personnel must be declared prior to the commencement of all competitions.

### **Reserve Shooters**

- Each State or Territory may have up to one (1) reserve shooter.
- Reserves for State or Territory Veteran Teams may shoot immediately after his/her team have completed shooting at each range and under the same coach, time permitting.

### **General**

- All nominated Teams will be in direct competition with each other.
- If after the commencement of a match a shooter is forced to retire due to unforeseen circumstances (other than gear malfunction) or illness the NRAA will convene a meeting with all Squad Captains who, exercising all due diligence MAY permit a replacement. The team emergency may continue in his/her place commencing with the next shot.
- In the event of unforeseen circumstances or where states would have a problem in selecting sufficient team members to compete, the NRAA, on request, shall convene a meeting of all Squad Captains before the start of the competition who, exercising all due diligence, and satisfied that Rule 2 of the Competition Rules is complied with, MAY permit a member from another State/Territory to be included in order that, that team can participate in the competitions. Only ONE additional person can be used per team.

## **21.4 SCHEDULE OF MATCHES AND CONDITIONS**

**THE MASTERS MATCH:** 2 convertible sighters, 15 shots to count at 900yds or 800m. TR Team possible score 375.  
Time Limit = 105 minutes.

**THE ERNIE MACE MATCH:** For F Standard Teams Match, 15 shots at 900yds or 800m.

**THE DON COOK TROPHY MATCH:** 2 convertible sighters, 10 shots to count at each of the following.  
TR Team possible score 1000.

i) 300yds ( 300 m ) - Time Limit 75 minutes

ii) 600yds ( 600 m ) - Time Limit 80 minutes

- iii) 900yds ( 800 m ) or 700yds ( 700 m ) - Time Limit 80 minutes
- iv) 1000yds ( 900 m ) or 900yds ( 800 m ) - Time Limit 90 minutes.

### **THE ROB RICHARDS-MOUSLEY MATCH**

For F Standard Teams, ranges will be the same as for The Don Cook Match. The Match will be conducted using the rules of 'F Class as per Chapter 20 of the current NRAA Standard Shooting Rules, together with such other subsidiary conditions as shall be decided by the NRAA Match Director following consultation with the Squad Captains and shot over the same ranges as the National Veteran TR Teams Matches on Full bore targets, as per SSRs Chapter 20.

### **Scheduling**

As a general rule the Masters Match and the Ernie Mace Match will be conducted on the afternoon of day one, and the Don Cook Trophy Match and the Rob Richards-Mousley Match on day two of the National Veteran Teams Championships. Opportunities for teams practice will be provided during the forenoon preceding the Masters Match.

F-Open and FTR matches shall be shot alongside F-Standard and under identical conditions to the F-Standard matches.

In the event of adverse weather or other unforeseen problems, the conditions of any Teams Match may be varied by the NRAA Match Director after consulting with a representative from each State at an emergency meeting convened for the purpose.

Where the number of team entries exceeds the capacity of a range, then the matches may be held by adding an additional day into the program provided sufficient notice has been given to the NRAA, the hosting organisation and provided that the overall program including individual matches is able to accommodate the increase.

## **21.5 COMPETITIONS TROPHIES**

**MASTERS MATCH Top Off-Rifle (TOR) and Top Coach (TC):** Medallions will be awarded to the TR shooter and his or her Wind Judge/Coach having the highest score in the Masters Match.

**DOUG SHEPHERD MEMORIAL:** Trophy awarded to the TR shooter having the highest aggregate in the Don Cook Trophy Match and a further trophy for his or her wind judge/coach.

**NATIONAL VETERANS' TR COMBINED DON COOK AGGREGATE:** Perpetual trophy awarded annually to the State having the highest combined score obtained by all ten shooters (two TR Teams) in the Don Cook Trophy Match. Possible score 2000.

**KOSI - FORD TROPHY:** Perpetual trophy awarded to the TR Team having the highest combined score obtained in the Masters and Don Cook Matches. Possible score 1375.

**COMBINED MASTERS/DONCOOK TOR AND TC:** Awarded to the individual and coach who obtain the highest TR Team aggregate score over the Masters Match and the Don Cook Match. Possible score 275.

**ERNIE MACE MATCH TROPHY:** Awarded to Team of F Class Standard shooters with the highest score in the Ernie Mace Match.

**ROB RICHARDS – MOUSLEY TROPHY:** Awarded to the F Class Standard Team with the highest aggregate score in "THE ROB RICHARDS-MOUSLEY MATCH".

**CLIFF JONES MEMORIAL MATCH TROPHY:** Awarded to the F Class Standard Team with the highest aggregate score in the ERNIEMACE MATCH and the ROB RICHARDS-MOUSLEY MATCH.

In 2024, inaugural Trophies for F-Open and FTR competitions are available for sponsorship and on approval of the NRAA, shall be presented matching the conditions of the ERNIE MACE MATCH TROPHY, the ROB RICHARDS-MOUSLEY MATCH and the CLIFF JONES MEMORIAL MATCH TROPHY

## MEDALLIONS

Medallions will be awarded as follows:

- NRAA Gold (2) for The Masters Match TOR and TC competition.
- NRAA Gold (7) for each member of the winning team (5 shooters, coach and reserve) in the Masters Match.
- NRAA Gold (14) for the National Veterans TR Combined Don Cook Aggregate Competition. 10 shooters, 2 Coaches, 2 Reserves.
- NRAA Gold (7) (including reserve) for The Kosi-Ford competition.
- NRAA Gold (2) will be awarded for the Combined Masters/Don Cook TOR and TC.
- NRAA Gold (7) will be awarded to the highest score in the Don Cook Match.
- NRAA Gold (7) for the Ernie Mace Match as well as the equivalent match in F-Open and FTR.
- NRAA Gold (7) for the Rob Richards-Mousley Match as well as the equivalent match in F-Open and FTR.
- NRAA Gold (7) for the Cliff Jones Memorial Match as well as the equivalent match in F-Open and FTR.

## 21.6 ANNUAL DINNER & PRESENTATION FUNCTION

The State or Territory hosting the National Veteran Teams Championships series will engage the services of a suitable function centre capable of providing a meal of a fully acceptable standard appropriate to the occasion.

The group hosting the function may invite dignitaries to attend at the expense of the NRAA, but the total number of invited guests shall not exceed four persons.

## 22. NATIONAL MATCH RIFLE CHAMPIONSHIPS

### 22.1 GENERAL

The National Match Rifle & Long Range F Class Championships are conducted under the control of the NRAA Limited over the distances of 1000, 1100 and 1200 yards or 900, 1000 and 1100 metres. The Championships shall be shot under the Australian String Shooting Application method and the program and all shooting is conducted under the NRAA Standard Shooting Rules.

### 22.2 PROGRAM

Competition shall be approximately every 18 months, or as approved by the NRAA, rotating amongst those states that have 1200 yard/1100 metre ranges and sufficient target capacity to host the event.

### 22.3 VENUE

Applications received to host the National Championships on behalf of the NRAA will be considered by the Board subject to range approval for competition to 1200 yards and sufficient target capacity. Where more than one long range is available in the State, the State Rifle Association will be asked to nominate the venue within their State.

### 22.4 COSTS

All local costs incurred in staging the match including medals, badges, markers, range and butts officers, targets and target material, range fees etc. (but not including ammunition costs), shall be the responsibility of the host State Association. To help defray these costs an entry fee may be imposed for individual and competing teams (See Section 2)

### 22.5 COMPETING SECTIONS

- Match Rifle Open Class
- Match Rifle Reserve Class (as defined in section 18.3 of the NRAA Standard Shooting Rules)
- FTR
- F (Open)

### 22.6 CONTROL

The Chairperson of the Australian Match Rifle Association will be the NRAA appointed Match Executive Officer for the National Championships. If the Chairperson is unavailable, a Match Executive Officer will be appointed by the NRAA.

The NRAA appointed Match Executive Officer shall have the right to vary, suspend, alter or otherwise change the programme or prize list to meet any unforeseen circumstances.

The NRAA appointed Match Executive Officer shall give an opening address at the commencement of competition on the first day.

### 22.7 PROGRAM

The individual program shall be conducted over 3 ½ days of competition.

**Note:** Super Centres (ICFRA 1000yd 127mm diameter) shall be placed inside the central bull. These are to be marked with a white spotter and recorded with an X on the Scorecard for all F Open and FTR competitors.

State Teams Competitions are held in conjunction with, and immediately following, the National Match Rifle & Long Range F Class Championships unless otherwise recommended by AMRA and approved by the NRAA.

Where target capacity on the range permits, the Long Range F Open and the Match Rifle Team competitions will be held concurrently.

The NRAA will appoint a Match Executive Officer for the State Teams event. The NRAA appointed Match Executive Officer shall have the right to vary, suspend, alter or otherwise change the programme or prize list to meet any unforeseen circumstances.

The NRAA appointed Match Executive Officer shall give an opening address at the start of the State Team Competitions.

### 23.1 MATCH RIFLE STATE TEAMS

#### 23.1.1 Rowlands Match

*The Rowlands Trophy was donated by Reg Rowlands and was the inaugural Match Rifle State Teams event, first competed for in 1997.*

##### 23.1.1a) Team Composition

Teams shall consist of between four (4) and six (6) members inclusive of Captain. Only four (4) shall shoot at each range. Any member of the squad may coach and coaches and captains may also shoot. The disposition of the team may be varied e.g. the coach at one range may be a shooter for subsequent range/s and vice versa.

Where a State is unable to field a full team, they may apply to the NRAA for members from any State or Territory not otherwise represented, to combine to form a team. With the NRAA approval, the combined team will be eligible to win the State Teams' Trophies.

Non-team members are permitted to score and check score.

##### 23.1.1b) Program

The Rowlands Match will generally be held on the day following the conclusion of the National Championships (Individual) events.

The Match is conducted over 1000, 1100 and 1200 yards with 2 Optional Sighters and Fifteen Counting shots for each of the 4 shooters.

##### 23.1.1 c) Time Limit

80 minutes for four firers at each distance.

### **23.1.1d) Awards**

The Rowlands Match is determined by the grand aggregate of all twelve scores recorded for each team.

- 1<sup>st</sup> place – Rowlands Perpetual Trophy and 6 Gold NRAA Medals
- 2<sup>nd</sup> Place – 6 Silver AMRA Medallions

### **23.1.1e) President's Trophy**

The President's Trophy & 2 Gold AMRA medallions are awarded to the top scoring shooter and coach in the Rowlands Match

### **23.1.2 Maloney Match**

*The Maloney Trophy was donated by Ken Maloney and was first competed for in 2008.*

#### **23.1.2a) Team Composition**

Teams shall consist of between four (4) and six (6) members inclusive of Captain. Only four (4) shall shoot. Any member of the squad may coach and coaches and captains may also shoot.

Where a State is unable to field a full team, they may apply to the NRAA for members from any State or Territory not already represented to combine to form a team. With the NRAA approval, the combined team will be eligible to win the State Teams' Trophies.

Non-team members are permitted to score and check score.

#### **23.1.2b) Program**

The Maloney Match will generally be held on the afternoon of Day 4 of the National Championships (Individual) events.

The Match is conducted at 1200 yards with NO Sighters and Sixteen Counting shots for each of the 4 shooters. With the approval of Match Executive Officer, the Maloney Match may be shot at 1100 yards where range conditions necessitate this.

#### **23.1.2c) Time Limit**

80 minutes for four firers.

#### **23.1.2d) Awards**

The Maloney Match is determined by the grand aggregate of all four scores recorded for each team.

- 1<sup>st</sup> place – Maloney Perpetual Trophy and 6 Gold NRAA Medals

### **23.1.3 Mincham Grand Aggregate Match**

*The Mincham Trophy was donated by Graham Mincham and was first competed for in 2011.*

#### **23.1.3a) Awards**

The Mincham Trophy is awarded to the State Team with the highest aggregate score from the Rowlands Match and the Maloney Match.

- 1<sup>st</sup> place – Mincham Perpetual Trophy and 6 NRAA Badges
- 2<sup>nd</sup> Place – 6 AMRA Silver Medals



## 23.2 LONG RANGE F CLASS STATE TEAMS

### Team Composition

The Long Range F Class State Teams are shot in accordance with the F Open requirements as stipulated in the Standard Shooting Rules.

Long Range F Class State Teams consist of a minimum of three (3) and maximum of five (5) persons per team. The team may consist of a Captain, Coach and 3 shooters per distance shot, the Captain or Coach may shoot as well however there is a maximum of 4 persons to shoot throughout the teams Matches (NSW Match and Victoria Match). All teams must be nominated in advance with the 3 primary shooters and reserve shooter (who may be the Captain or Coach) written onto the scorecard. Shooters may be changed between ranges as the Captain sees fit to manage their team.

Non-team members are permitted to score and check score.

State Teams Competitions for Long Range F Class are conducted under the control of the NRAA Limited and shot under the NRAA Standard Shooting Rules for Team competitions.

State Teams Competitions are generally held in conjunction with Match Rifle Teams event, and immediately following, the National Match Rifle & Long Range F Class Individual Championships unless otherwise recommended by AMRA and approved by the NRAA.

Where target capacity on the range permits, the Long Range F Open and the Match Rifle State Team competitions will be held concurrently.

The NRAA will appoint a Match Executive Officer for the State Teams event. The NRAA appointed Match Executive Officer shall have the right to vary, suspend, alter or otherwise change the programme or prize list to meet any unforeseen circumstances.

The NRAA appointed Match Executive Officer shall give an opening address at the start of the State Team Competitions.

Note: Super Centres (ICFRA 1000yd 127mm diameter) shall be placed inside the central bull. These are to be marked with a white spotter and recorded with an X on the Scorecard for all F Open Teams events

### 23.2.1 New South Wales Match

*The New South Wales Trophy was donated by New South Wales F Open shooters and was first competed for in 2013.*

#### 23.2.1a) Composition

Refer Section 23.2 above

#### 23.2.1b) Program

The NSW Match will generally be held on the day following the conclusion of the National Championships (Individual) events.

The Match is conducted over 1000, 1100 and 1200 yards with three (3) Optional Sighters and Fifteen Counting (15) shots for each of the three firers.

#### 23.2.1c) Time Limit

60 minutes for the three firers at each distance.

### 23.2.1d) Awards

The NSW Match is determined by the grand aggregate of all nine scores recorded for each team.

- 1<sup>st</sup> place – NSW Perpetual Trophy and 5 Gold NRAA Medals
- 2<sup>nd</sup> Place – 5 Silver AMRA Medallions

### 23.2.1e) President's Trophy

The President's Trophy & 2 Gold AMRA medallions are awarded to the top scoring shooter and coach in the NSW Match

## 23.2.2 Victoria Match

*The Victoria Trophy was donated by Victorian F Open Shooters and was first competed for in 2013.*

### 23.2.2a) Composition

Refer Section 23.2 above.

### 23.2.2b) Program

The Victoria Match will generally be held on the afternoon of Day 4 of the National Championships (Individual) events.

The Match is conducted at 1200 yards with NO Sighters and Sixteen Counting shots for each of the 3 shooters.

With the approval of AMRA Executive, the Victoria Match may be shot at 1100 yards where range conditions necessitate this.

### 23.2.2c) Time Limit

60 minutes for three firers at each distance.

### 23.2.2d) Awards

The Victoria Match is determined by the grand aggregate of all three scores recorded for each team.

- 1<sup>st</sup> place – Victoria Perpetual Trophy and 5 Gold NRAA Medals

## 23.2.3 South Australia Grand Aggregate Match

*The South Australia Grand Aggregate Trophy was donated by South Australian F Open shooters and was first competed for in 2013.*

### 23.2.3a) Awards

The South Australia Trophy is awarded to the State Team with the highest aggregate score from the New South Wales Match and the Victoria Match.

- 1<sup>st</sup> place – South Australia Perpetual Trophy and 5 NRAA Badges
- 2<sup>nd</sup> Place – 5 silver AMRA medallions

## 24. AUSTRALIAN CHAMPION OF CHAMPIONS

Decided at May 2007 Board Meeting to hold an annual Match immediately prior to the NRAA National Championships at which each State or Territory Champion would compete against each other for the Title. Each State and Territory to contribute \$300 per annum to the NRAA, which is to distribute the funds towards reimbursing part of the travel costs of the competitors. The allocation of funds will be made following submission of receipts from all the competitors.

### 24.1 MATCH CONDITIONS and AWARD

Entry fee and \$300 travel contribution must accompany nomination.

### 24.2 PROGRAM

15 shots @ 300, 500, 600, 900, 1000 yards

Unless otherwise advised contestants are required to be in attendance by 0800 hours on each day of the contest

### 24.3 EQUIPMENT CHECK

Checks will be conducted at 0800 hours prior to the commencement of the competition or at any other designated time. Ammunition and trigger testing may be conducted on a random basis at any time during the event.

### 24.4 TIES

A tie shall be decided by a shoot off at 1000 yards

### 24.5 MATCH CONDITIONS

The NRAA Match Executive Officer and CRO will conduct the draw. The centre targets moving out will be utilized wherever possible. Draw procedure: 1st card drawn LEFT of target; 2nd card drawn RIGHT of target, 3rd card drawn LEFT, 4th card RIGHT of next target, etc Those who draw LEFT at the first range move LEFT three (3) target each distance. Those who draw RIGHT at the first range move RIGHT four (4) targets each distance. Each firer alternate LEFT/RIGHT at every distance change

### 24.6 RANGE STAFF

All range staff will be co-ordinated by the venue owners; The National CRO will always be invited to officiate at this event on behalf of the NRAA The NRAA will nominate the Match Officer The NRAA EO will provide statistics The NRAA will provide the cards.

### 24.7 ADDITIONAL AWARDS

ACM Champion

A perpetual trophy has been presented to the NRAA by the Percy Pavey estate for the recording of past and future champions which shall be held by the current Champion.

### 24.8 VENUE

The NRAA HQ range or as determined effective from 2006.

## 25. AUSTRALIA CUP

This competition is deemed essential training for Australian competitors for international events. Australia Cups (AC) conducted to be used for selection into the Commonwealth Games, the Commonwealth Shooting Federation Championship events and Oceania Shooting Federation Championships.

Australia Cups will be conducted as scheduled by the NRAA to provide an appropriate selection path for the relevant upcoming event. Each Australia Cup shall be conducted immediately following the relevant NRAA Annual Championship or State/Territory Championships as scheduled.

## **26. ROYAL KALTENBERG WORLD TARGET RIFLE CHAMPIONSHIP CUP**

### **26.1 HISTORY**

The Royal Kaltenberg Cup is the property of Mr Geoff Ayling who has donated the trophy for perpetual competition, which was inaugurated in Perth September 2001.

The Cup was first competed for in 1980 at Bisley. The competition consisted of 12 finalists firing two sighters and string of 20 counting shots at 1,000 yards. Mr Geoff Ayling was the outright winner of the Cup.

The Cup will be retained in perpetuity by the NRAA and will not leave Australia.

Should any State Association wish to have the Cup on display for the competition, then the cost of transportation of the Cup, from and to NRAA, will be borne by the Host State.

### **26.2 CONDITIONS**

The Cup may be contested at any international event at which an official Australian touring team is in attendance. NRAA to duly notify the country concerned, should they wish to avail themselves of the competition.

Nationally the Cup may be competed for at a State Queens when the Open national Teams event is conducted. The final 20, or a number as agreed by NRAA at their discretion, of the Queen's Grand Aggregate qualifying [i.e. aggregate of lead up and Queens]

### **26.3 AWARD**

A suitable trophy will be presented to the winner by the NRAA. In addition the NRAA will have the base of the trophy engraved with the winners name and score, NRAA logo badge [burgundy & silver to be awarded], supplied by NRAA.

### **26.4 DISTANCES**

The event will be conducted over the distance of 1,000 yards. Two optional sighters, with 15 counting shots.

### **26.5 AMMUNITION**

The approved factory hand load or loaded round of the country in which the competition is being held, or the country of the competitor.

### **26.6 RIFLES**

Rules prevailing of the host nation.

### **26.7 TIME LIMIT**

As per Standard Shooting Rules of NRAA.

### **26.8 NOTES**

These conditions can not be altered without the joint approval of G Ayling and the NRAA.

## 27. THE MACE MEDAL

The Mace Medal was introduced into the National Championships to be contested alongside the Royal Kaltenberg Cup. The competition is held for F Standard, F Open and F/TR.

### 27.1 CONDITIONS

Nationally the Cup may be competed for at the National Championships. The final four from each discipline or a number as agreed by NRAA at their discretion, of the Queen's Grand Aggregate qualifying [i.e. aggregate of lead up and Queen's].

### 27.2 ELIGIBLE

That the qualifying conditions be exactly the same as the Kaltenberg Cup with the following numbers selected to compete:-

- (a) F Standard – the top 4 shooters in the preliminary Grand Championship.
- (b) F Open – the top 4 shooters in the Preliminary Grand Championship.
- (c) F/TR – the top 4 shooters in the Preliminary Grand Championship
- (d) The above numbers may be varied from year to year as more experience is gained of numbers competing.

### 27.3 AWARD

A suitable trophy will be presented to the winner by the NRAA. In addition the NRAA will have the base of the trophy engraved with the winners name and score, NRAA logo badge [burgundy & silver to be awarded], supplied by NRAA.

### 27.4 DISTANCES

The event will be conducted over the distance of 1,000 yards. Two optional sighters, with 15 counting shots.

### 27.5 AMMUNITION

The approved factory hand load or loaded round of the country in which the competition is being held, or the country of the competitor.

### 27.6 RIFLES

Rules prevailing of the host nation.

### 27.7 TIME LIMIT

As per Standard Shooting Rules of NRAA.
